CTS EVENTIM: Tilman Wink appointed new General Counsel

Until 2018, he worked for a series of renowned major law firms, including Freshfields Bruckhaus Deringer, Simmons & Simmons and Baker McKenzie. His main areas of focus there included corporate and capital markets law, financial law and private M&A. Tilman spent the last five years as General Counsel, Chief Compliance Officer and Company Secretary for SIGNA Sports United Group in Berlin and Frankfurt. During this time, he set up the group's legal department, was involved in its IPO on the New York Stock Exchange, handled the legal aspects of the acquisition of the Wiggle group, and helped establish SIGNA's tennis group through several international acquisitions.
