CTS EVENTIM ermutigt zur Meldung von Fehlverhalten über die internen Meldewege. In Anbetracht der EU-Whistleblowing-Richtlinie haben die EU-Mitgliedstaaten Behörden benannt (oder werden dies in Kürze tun), die auch Meldungen über Fehlverhalten als externe Meldewege entgegennehmen.

CTS EVENTIM encourages reporting of misconduct via the internal reporting channels. However, in view of the EU Whistleblowing Directive, EU member states have defined (or will soon define) designated authorities that also accept reports on misconduct as external reporting channels.
